
OBJECTS AND AIMS OF THE TRUST

1. To organize for improving the World Language, English, and to promote the human resources in our locality to be used in the field of labour world wide.
2. To provide free I.T. education to financially backward students belonging to backward caste and community.
3. To start Schools, Colleges, I.T. Institutions, Nursing Medical and Para-medical Institutions and Job Training centres.
4. To improve the formation of good conduct, patriotism sports and cultural activities and intelligence in studens by starting residential schools.
5. To start orphanages and home for the neglected.
6. To provide financial assistance to weaker section of the society.


CONSTITUTION

The Management of the Trust will be conducted by a Trust Board consisting of not less than 6 members. The founder members will be the permanent members of the Trust. The decision taken by the Trust Board with the approval of the founder members will be valid. The Trust Board shall carryout the decision taken by the majority of the members. There must be a Chairman and a Secretary to the Trust. The Chairman shall preside over the meetings of the Trust and shall supervise and give direction to the day to day functioning of the Trust. The Chairman shall represent the Trust before any Government, Quasi Government, Local Self Government

to the decisions of the Trust Board. The Secretary shall convene all meetings of Trust and shall maintain the income and expenditure accounts and shall prepare the Annual Budget and Annual Receipts No.1 of us is the Chairman and No.2 of us is the Secretary of the existing Trust Board.

In case if voting is required in any matter and if equal votes were obtained by the members the Chairman has the power to cast his vote.

As per the decisions of the majority, the trust members have the power to make rules and regulations for the control and welfare of the efficient and smooth functioning and management of the institutions of the Trust.

The meetings of the Trust Board shall be held once in a month and the meeting of the trust members shall be held once in a year. The quorum for any meetings shall be more than half of its members. All the accounts of the Trust shall be audited annually by an Accountant appointed by the Trust Board. The term of office of the Trust Board shall be five years.

The Trust Board shall have the power to appoint new members and the power to take action against the members who are working against the Trust. The accounts of the Trust shall be in the names of the Chairman and the Secretary of the Trust. For the functioning of the Trust, any donation from the home country and foreign country and any help from the Government can be accepted and any procedure can be opted as per the decision of the Trust Board meeting.
